Along with a \$5 check or money order made out to HRSFA. If we do not receive payment by the March 4<sup>th</sup> deadline, the registration fee will increase to \$10 at the door. As soon as we receive your form, you will have a space reserved at the art show for your work, which we will hold for you until the end of set-up on the morning of Saturday, March 19<sup>th</sup>. At this point, if your artwork has not been received, your place will be opened up to all artists on a first-come, first-serve basis. However, if you anticipate arriving later than this, please get in contact with us to discuss alternative arrangements. If you are mailing your artwork, we would encourage you to mail this form with your art to ensure that your entry registration is processed as quickly as possible. However, please note that the deadline for RECEIPT of both your registration form and your mailed-in artwork is **Friday, March 4th, 2011.**

Identical copies or prints occupy no display space and thus are not considered one of the 10 entries. Please indicate whether prints of any entry will be made available, and for what price. Any mounted or otherwise "display-ready" print you would like to sell requires a separate entry. The "minimum bid price" refers to the lowest price at which you are willing to auction a particular piece of art. The "Quick Sale" price is the price at which you are willing to immediately sell that piece, regardless of bidder activity. If the "Quick Sale" price is met by a buyer, the piece is sold instantly. This method of sale is optional for the artist. If you do not wish to sell a piece, please write "NFS" (Not For Sale) wherever the issue of price for that particular piece arises.
